THE SERVICES ARE COMPREHENSIVE WITH THE CORNERSTONES BEING PARENT AND CHILD EDUCATION, HEALTH, AND FAMILY AND COMMUNITY ASSET BUILDING. EARLY HEAD START AND HEAD START ARE PROGRAMS COMMITTED TO GIVING EVERY VULNERABLE CHILD AN OPPORTUNITY TO SUCCEED.
